Pelican Harbor Seabird Station is dedicated to the rescue, rehabilitation and release of sick, injured or orphaned brown pelicans, seabirds and other native wildlife; and the preservation and protection of these species through educational and scientific means. A total of 2,117 patients of 131 native species were treated in 2022 and over 5,854 wildlife calls were fielded by staff and volunteers.**
